Proposals to Amend DKG Delaware State Organization Bylaws

2021

Currently, proposals for amendments to the Alpha Tau State Bylaws shall be voted upon every two (2) years at the state convention in odd-numbered years. These bylaws may be amended by a two-thirds (2/3) vote, provided notice of the proposed amendments have been published at least forty-five (45) days prior to the convention. Alpha Tau State Standing Rules may be adopted, amended, or rescinded at any biennial convention by a majority vote. All proposed amendments shall have been approved by a two-thirds (2/3) vote of the state Executive Board before being presented to the state convention.

Proposals to Amend Alpha Tau State Bylaws

Article IV. Section 2. D.

Current: All dues and fees, state and international, shall be collected by the chapter treasurer and forwarded to the state treasurer.

- Propose: Amend to read: The membership year is July 1 June 30. A member shall pay annual state dues and fees no later than June 30 for the following year. All international dues and fees shall be collected by the chapter treasurer and forwarded to international. All state dues and fees shall be collected by the chapter treasurer and forwarded to the state treasurer.
- **Rationale:** Aligns with International rules. The state treasurer no longer collects or forwards chapters' dues and fees to international.

Fiscal impact: None

Add to Article IV. Section 2. E

Propose: Add to read: For membership or reinstatement commencing between July 1 and December 31, the member shall pay induction fee (new member only), international and state dues, and scholarship fee (if applicable) for the current year. For membership commencing on or after January 1, the member shall pay one-half the international and state membership dues, induction fee (new members only) and the scholarship fee (if applicable). Immediately thereafter, the international portion shall be sent by the chapter treasurer to international, and the state portion shall be sent to the state treasurer.

Rationale: Complies with international rules

Fiscal impact: Loss of one-half membership dues and fees

Add to Article X. Section 1. A. and B.

Current:

The number of scholarships and the amount of each shall be recommended by the state Scholarship and World Fellowship Committee and adopted by the Executive Board.

Rules governing the administration of the scholarship program shall be recommended by the state Scholarship and World Fellowship Committee and adopted by the Executive Board.

Propose: Insert "state" to read:

The number of scholarships and the amount of each shall be recommended by the state Scholarship and World Fellowship Committee and adopted by the state Executive Board.

Rules governing the administration of the scholarship program shall be recommended by the state Scholarship and World Fellowship Committee and adopted by the state Executive Board.

Rationale: Clarify which Executive Board

(3) U.S. Forum Liaison

Propose: Delete Article IX. Section 1. C. (3)


Rationale: As written in Article IX. Section 2. G., the state president is to appoint one member of the Educational Excellence Committee as U.S. Forum liaison. This would eliminate to need for a U.S. Forum committee.

Fiscal Impact: None

Proposals to Amend DKG Delaware State Organization Standing Rules 2021

Currently, proposals to the Standing Rules may be adopted, amended, or rescinded at any biennial convention by majority vote.

Article 7.1 (4) The Delaware State Organization Founders' Scholarship Fund
Current: Reasonable standards as to health, personality, scholarship and professional services shall be considered and must be met by the candidate.
Propose: Amend to read: Reasonable standards as to scholarship and professional services shall be considered and must be met by the candidate.
Rationale: Outdated and not measurable
Fiscal Impact: None

Article 7.2.a.(1) The May B. Leasure Grant-in-Aid

Current: (1) First consideration shall be given to applicants related to Delta Kappa Gamma members of Delaware State Organization (Delaware).
Propose: Amend to read: First consideration shall be given to applicants related to Delta Kappa Gamma members of Delaware State Organization.
Rationale: Repetitive
Fiscal Impact: None

Article 7.2.a.(3) The May B. Leasure Grant-in-Aid

Current: (3) Applicants must meet reasonable standards relating to general health, personality, professional and/or community services, as well as demonstrate excellence in scholarship.

Propose: Delete

Rationale: The general health and personality reference is outdated and not measurable. The remainder will be integrated into part 6.

Fiscal Impact: None

Article 7.2.a. The May B. Leasure Grant-in-Aid

Propose: Add: The applicant will need to complete an essay on professional goals and the benefits of receiving the grantin-aid.

Rationale: The essay is in the application but is not currently listed in the criteria for determining eligibility.

Fiscal Impact: None

Article 7.2.a.(6) The May B. Leasure Grant-in-Aid

Current: The applicant will be judged on scholastic achievement, quality and content of the submitted essay, and financial need.

- **Propose:** Amend/Add (6) The applicant will be judged on scholastic achievement, school and community activities, quality and content of the essay, letters of recommendation, and financial need.
- **Rationale:** This summarizes everything the applicants will be judged on; it encompasses what is in the old part (3) and covers all parts of the application. Professional and/or community services has been changed to school and community activities to be aligned with student activities. Also, both school and community activities are relevant, rather than and/or.

Fiscal Impact: None

Article 7.2.a.(4) The May B. Leasure Grant-in-Aid

Current: (4) Sex, Race or religion will not affect the awarding of this grant-in-aid.

Propose: Amend: (4)Race, color, national origin, sex, age, religion, disability, sexual orientation or gender identity will not affect the awarding of this grant-in-aid.

Rationale: This will update the equal opportunity clause.

Fiscal Impact: None
